1.0 **Welcome**

Welcome to the RoadRunner Harley Owners Group Road Captain Program. The intent of this document is to give both prospective and existing Road Captains helpful information in promoting a safe group riding environment and to outline the responsibilities of RoadRunner Harley Owners Group Road Captains. Please keep in mind that these guidelines are not intended to restrict your freedom, but instead, to help ensure that we all return home safely.

Our suggestions cannot encompass every possible set of circumstances, and they are intended to serve as a basic guide for most situations. We ask each person to read, understand, and apply these guidelines, using their best judgment.

Please remember that YOU have the ultimate responsibility for YOUR safety, and always ride within your capabilities and that of your machines.

We hope you will enjoy riding with us

2.0 Congratulations

You have volunteered for the most challenging and rewarding position within RoadRunner H.O.G., or any other motorcycle Chapter or Club. Once you have been accepted as a RoadRunner H.O.G. Road Captain and earned your new Road Captain's rocker, you will have joined a very special team that will help plan, organize, and execute our Chapter rides. The following guidelines have been developed to give you a basic understanding of the recommendations and responsibilities for our Road Captains, and the methods we employ to help ensure everyone's safety during our rides.

3.0 Objectives

- 3.1 Provide for the safety and welfare of all individuals within the riding group, and any surrounding motorists and/or pedestrians.
- 3.2 Lead the group to its destination in a well organized, disciplined, and safe manner.
- 3.3 Avoid creating hazardous situations.

4.0 Road Captain Recommended Qualifications

- 4.1 Maintain a current and valid Arizona motorcycle driver's license and insurance, with no less than the MINIMUM required for street riding purposes.
- 4.2 CPR/First Aid Class certification is a bonus to the Chapter

- 4.3 Successfully complete of a CMSP or MSF Advanced (experienced) Rider course is a bonus to the Chapter

- 4.4 Read and understand the RoadRunner “Group Riding Suggested Do’s and Don’ts” document
- 4.5 Participate in RoadRunner Road Captain meetings
- 4.6 Participate in a probationary orientation process

5.0 Road Captain Responsibilities

5.1 Lead

- 5.1.1 Has full charge of the group until arrival at the destination.
- 5.1.2 Will conduct rider’s briefing prior to departure.
- 5.1.3 Will lead the group in a manner consistent with the objectives and guidelines as stated herein, and will execute his or her best judgment in situations not specifically covered in these guidelines.
- 5.1.4 Will brief all other assigned Road Captains as to route, responsibilities, and other details pertinent to the ride prior to departure.
- 5.1.5 Will assign Road Captains (Lead, Shotgun, Sweeps) in the event of a formation split.
- 5.1.6 Will assign Road Guards and explain purpose and responsibilities.
- 5.1.7 During the ride the Lead will establish and maintain a uniform speed with consideration of safe roads, traffic, weather conditions, and riders’ ability.
- 5.1.8 The Lead will be responsible for initiating all

maneuvers within traffic in a “Safety First” manner leading the formation in a staggered double row, in one traffic lane.

- 5.1.9 Will be responsible for the final decision with regard to ride termination due to inclement weather, hazardous conditions, or other difficult or unsafe conditions.
- 5.1.10 Will instruct any rider to ride in a specific position of the group, or leave the group entirely, for reasons of misconduct, disorderly or unsafe riding, or faulty/unsafe equipment.
- 5.1.11 Will be responsible for bringing:
 - 5.1.11.1 Well maintained First Aid Kit to the ride.
 - 5.1.11.2 A well stocked tool kit for the ride.
 - 5.1.11.3 If possible, a cell phone for 911 purposes.
- 5.1.12 Locate other cell phones, tool kits, and first aid kits.
- 5.1.13 Designate a 911 notification caller within the group.
- 5.1.14 Will be responsible for the Road Captain sign-in sheet, to be signed before each event, and will be responsible for providing it to the Head Road Captain by the next membership meeting.
- 5.1.15 Will not consume any alcohol until relieved at the completion of the ride.
- 5.1.16 Will be at the head of the group, and will ride just to the left of the lane center.
- 5.1.17 Will maintain a safe following distance by using the MINIMUM 2 second rule between the group and any vehicle ahead. This distance may be increased at the discretion of the Lead Road Captain but should not be decreased.

5.2 Shotgun

- 5.2.1 Contact the Lead RC in advance of the ride to get the

- route info and check the maps or pre-ride the route.
- 5.2.2 Be prepared to act as Lead Road Captain for a second group if needed.
- 5.2.3 Become the Lead Road Captain if the assigned Lead RC cannot make or complete the ride for any reason.
- 5.2.4 Assist Lead with pre-ride duties.
 - 5.2.4.1 Look for non-members and complete release forms.
 - 5.2.4.2 If toll money is required during the ride, Assist with collecting
- 5.2.5 On the road you are the Right hand eye for the group.
- 5.2.6 Right turns and right Lane changes can also be a function of the Shotgun if worked out and agreed upon prior to the start of the ride.

5.3 Sweep

- 5.3.1 Will ride at the rear of the group, unless required to take on the responsibilities of the Lead Road Captain position.
- 5.3.2 May be required to assume the duties of Lead Road Captain in his or her absence or in a separated formation condition.
- 5.3.3 Will be responsible for bringing a First Aid kit to each ride.
- 5.3.4 Will be responsible for bringing a well stocked tool kit to each ride.
- 5.3.5 Will be observant of any hazardous conditions or conduct, take immediate corrective action as appropriate, and inform the Lead Road Captain at the earliest safe opportunity. **The urgency to inform the Lead Road Captain must be left to the discretion of the observing Road Captain.**
- 5.3.6 Will instruct any rider to ride in a specific position of the group, or leave the group entirely, for reasons of misconduct, disorderly or unsafe riding, or faulty/unsafe equipment.

- 5.3.7 Will not consume any alcohol until relieved at the completion of the ride.
- 5.3.8 Lane protection is the Sweep's primary responsibility. On the highway, as the group prepares to make a lane change, the Sweep will make the lane change first as soon as it is safe to do so. The Sweep protects the lane, keeping it clear for the entire group to move into this lane.
- 5.3.9 In the event a member of the group stops or pulls over to the side, for whatever reason, the Sweep will be the only designated one to stop and assist the member.
- 5.3.10 In the event of an injury to a member of the group, it is the responsibility of a sweep to provide aid and comfort to the injured rider in-so-far as possible. The other sweep is responsible for contacting authorities for medical assistance, if necessary.

5.4 Road Guard

- 5.4.1 This position is used primarily for traffic control to ensure the safety of the sweeps during a breakdown or accident, especially on hilly and twisty back roads.
- 5.4.2 Usually positioned in front of the sweeps.
- 5.4.3 They can also move up when the group is split on a ride and assume a temporary lead position. This leaves the sweeps in the back to do their assigned jobs.

5.5 All Road Captains

- 5.5.1 Are expected to be properly equipped and "On Duty" while riding in Group Formation.
- 5.5.2 Will not consume any alcohol until relieved at the completion of the ride.

6.0 Ambassadors of Safety

6.1 All Road Captains are “Ambassadors of Safety”. This role includes seeking out new members and explaining the fun aspects of RoadRunner H.O.G. rides and events and being role models to others by adhering to our group riding “Do’s and Don’ts”.

Road Captain Check List

- ☐ Greeting, Everyone Sign-in, Guest sign Release form
- ☐ Any New members want to introduce themselves
- ☐ Identify Lead, Shotgun and Sweep, other RC assignments
- ☐ Who has a First aid kit, any trained personnel
- ☐ Discuss Destination and Route, Identify smallest tank
- ☐ We ride in a Staggered formation: maintain spacing
 - ☐ Stay in own wheel track
 - ☐ Stay 2 sec behind rider in your wheel track and 1 sec behind ride opposite wheel track
- ☐ If we move to Single file: maintain your spacing
 - ☐ Which means you may Use full lane, 2 sec behind rider ahead
- ☐ Please use & pass back hand signals
 - Two fingers, staggered formation
 - One finger, single file
 - Point to road hazards with hand or foot
 - Left, Right, slow down, stop
 - Tighten up our Stagger Formation
 - On your own signal
- ☐ Do not change lanes until Lead moves over - Follow the Leader
- ☐ Maintain position during a ride
- ☐ Let vehicles into formation if needed
- ☐ High Beams off. Sweeps are the exception
- ☐ New riders, we suggest may ride front or rear, Lead RC choice
- ☐ Lead Road Captain will slow for stale green light; stop on yellow
- ☐ Incidents: only Sweep stops (First aid kit if needed)
- ☐ If Group gets separated: explain use of cookie crumb
- ☐ Early departures ride in rear, let Lead know, wave off, other riders move forward to fill gap when safe
- ☐ Round Trip or Destination Ride? - No drinking alcohol or use of recreational drugs while on chapter ride
- ☐ QUESTIONS or COMMENTS
- ☐ Ride Your Own Ride – Be responsible - Have FUN and Ride SAFE

1. I know the nature of the **EVENT(S)** and the **Minor's** experience and capabilities, and believe the Minor to be qualified to participate, in the **EVENT(S)** or enter into restricted areas where the **EVENT(S)** are conducted. IF I OR THE **MINOR** BELIEVE ANYTHING IS UNSAFE, I WILL INSTRUCT THE **MINOR** TO IMMEDIATELY CEASE OR REFUSE TO PARTICIPATE FURTHER IN THE **EVENT(S)** AND/OR LEAVE THE RESTRICTED AREA.
